Nomination process for the same is to follow the following schedule (tentative):-

Date	Event
23/06/2020	Activation of Nomination Window (at 0000 hrs). (Link provided below.)
25/06/2020	Closure of Nomination Window (at 2359 hrs).
26/06/2020	Scrutinization of Nominations filed.
26/06/2020	Publication of List of Eligible Nominees (after 1900 hrs).

Nomination procedures:-

A. Eligibility:-

A1. Members who desire to file nomination must have their Membership Fees cleared upto **April 2020**, as on **22/06/2020, 11:59:59 pm**.

A2. Members must be sound about issues related to Biodiversity Conservation, round the globe.

B. Procedure:-

B1. Nomination Window will be opened on **23/06/2020 at 12:00:00 am midnight**. Nomination can be filed ONLY in online mode, via Google Form [URL: - <https://forms.gle/ER8c12iUe3gNMmt16>]

B2. Every candidate desiring to file nomination will have to enter correct information in four fields, viz. Name, E-mail ID, WINGS I-card Number and a small note on why he/she

intends to join the Governing Body (Word Limit:- 50 words). **None of the fields can be left out empty.**

B3. Nomination Window will be closed on **25/06/2020 11:59:59 pm**. No request for filing the nomination shall be entertained post the deadline.

B4. Filing of nomination, more than once, will render cancellation of all nominations filed by the concerned candidate.

B5. Any discrepancy, incomplete information or misinformation in filing process, shall render cancellation of nomination of the concerned candidate. Failure of meeting the requirement mentioned in Clause A1 shall also render the same.

B6. There shall be an option of cancellation if the nominee desires to. He/She has to address the Joint Secretary-in-Charge, stating his/her name, WINGS ID Card no, and his/her reason for withdrawal of nomination, via an email to wildwingsbengal@gmail.com, 4pm evening of by 26/06/2020. Nomination shall be cancelled, if only the authority decides the reason is good enough. No such requests shall be entertained thereafter.

Special Note:-

The Model Code of Conduct is hereby promulgated and will stay in force till new Governing Body swears in. No new events or programs shall be declared during the said period. Previously declared programs shall, however, be conducted, if scheduled.
