Notice for the Election of the Governing Body for FY 2020-2021

With reference to the previous notice bearing Ref.no.:- WINGS/2020/GBE/001, dated 22/06/2020, it is hereby notified that the Election of the Governing Body for FY 2020-2021, will take place, ONLY, if there are more than 11 eligible nominations. A number equal to 11 or less than that will lead to automatic election of the nominees to Governing Body, since the total no.of posts in the Governing body is 11.

In case the no.of eligible nominations exceed 11, Election will be undertaken as per the following schedule and procedure:-

Date	Event
27/06/2020	Activation of Election Window (at 0000 hrs). (Link to be notified later on.)
27/06/2020	Closure of Election Window (at 2359 hrs).
28/06/2020	Scrutinization of Votes casted.
28/06/2020	Publication of Results of Election (after 1900 hrs).

C. Eligibility

C1. All Members of the current Governing Body, General Body and Advisory Body, having their Membership Fees cleared upto **April 2020**, as on **26/06/2020, 11:59:59 pm.**, shall be considered eligible for casting votes.

D. Procedure:-

D1. Nomination Window will be opened on **27/06/2020 at 12:00:00 am midnight**. Nomination can be filed ONLY in online mode, via Google Form. [URL will be notified on 26/06/2020, via Whatsapp and website]

D2. Every voter shall have to enter information in following fields, viz. Name, WINGS I-card Number and then enter the 11 names or put a tick mark on 11 names of eligible nominees, whom he/she intends to see as a member of the newly elected Governing Body. **None of the fields can be left out empty.**

D3. Election Window will be closed on **27/06/2020 11:59:59 pm**. No request for filing the election choices shall be entertained post the deadline.

D4. Submission of election choices, more than once, will render cancellation of all nominations filed by the concerned voter. In case he/she chooses more than 11 eligible nominees, the first 11 will be put under consideration. Once vote has been casted, no option for correction or alteration shall be entertained.

D5. Any discrepancy, incomplete information or misinformation in submission process, shall render cancellation of vote of the concerned voter. Failure of meeting the requirement mentioned in Clause C1 shall also render the same.
